INTERNATIONAL ADMISSION PACKET

International Students must submit a complete "International Admission Packet" with all documents listed below BEFORE admission can be granted. All fee amounts are subject to change upon approval by the College Board of Trustees, the Chancellor, and California legislature. **Application Deadlines: for Spring Semester – November 1st, for Fall Semester – May 1st.**

- _____ (1) **Official TOEFL** (Test of English as a Foreign Language) test result of **450** (paper-based test), **133** (computerized test), or **45** (internet-based test) **minimum (NO photocopy)** sent from ETS. Our TOEFL Institutional code is 4670; the TOEFL bulletin may be obtained at no charge by writing to Test of English as a Foreign Language, P.O. Box 6155, Princeton, New Jersey 08541-6155, telephone (609) 921-9000, (website: www.toefl.org) or IELTS 6.0. Students from Japan may submit **STEP Eiken 2A**. If you are in the Sacramento area, you can take our SCC ESSAY + ESL or ENGLISH test results comparable to TOEFL level www.scc.losrios.edu/~matric/assessment/
- _____ (2) Evidence of financial ability to meet minimum costs of US **\$15,600.00**. Request verification of funds or balance from the bank (**Official bank letter**). If the sponsor is an U.S. citizen, USCIS **Affidavit of Support** (I-134 Form) with supporting documents is required. Form available at USCIS website: www.uscis.gov. If you are sponsored by agency, submit official scholarship letter addressed to SCC listing dates of coverage (**NO photocopy**).
- _____ (3) **Official High School diploma** showing graduation and transcript (**NO photocopy**). **Official College transcript(s) if attending U.S. colleges**. Non-English documents must be accompanied by translated copies (**NO photocopy**). If currently in the last year of High School, request verification from the school principal to certify the expected graduation date.
- _____ (4) One small **photograph** (passport size) with your name printed on back.
- _____ (5) SCC **International Admission Packet** fully completed and signed.
- _____ (6) Los Rios Community College District **Application for Enrollment, select SCC only**. You can complete an online application at www.scc.losrios.edu and print the confirmation page. If you wish to fill out a paper Application for Enrollment, you can download the Application and complete everything fully. Mail the paper application or the confirmation page with all admission requirements. If you are on student visa or plan to apply for a student visa, on question No. 4, Citizenship Status, click on student visa and self identify yourself as F-1. Social Security Number is not needed to complete the application .
- _____ (7) **US\$ 50.00** nonrefundable Application for Enrollment fee payable to **Sacramento City College** in the form of a check, money order or cashier's check (**do not send cash**) payable on a United States bank. Print applicant's name on face of check (and SCC Identification Number if available). Your application will not be processed if there is no fee.

Note: Upon arrival at the college, show proof of health & medical insurance coverage. All F-1 students are required to purchase a mandatory LRCCD/SCC Health & Medical Insurance or a comparable plan (**in English**) with coverage dates.

TRANSFER STUDENTS: International Students who have been attending school in the United States are also **REQUIRED** to submit **items 8 through 11** below before admission is approved.

HELPFUL HINT: Collect all admission requirements and mail them as ONE COMPLETE PACKET. A completed package will speed the evaluation process. If TOEFL score or transcript is delayed, tell us the approximate date when we can expect to receive the official documents. Turn in everything before deadline dates to allow mailing, processing, and American Consulate visa interview time lines.

HEALTH & MEDICAL INSURANCE: Doctor and dental care must be covered by the student. In the U.S. health care is extremely expensive, and there are *no free* medical facilities. International students at SCC must have health insurance coverage and it must be valid in the United States. All enrolled international students will be required to purchase international health insurance from a Los Rios Community College District (LRCCD) recommended provider or show proof of coverage. If you do not meet the above registration procedure, registration will be cancelled. Note that “travel insurance” plans are not acceptable. EMPLOYMENT: On-campus employment is limited and employment opportunities off-campus are restricted under Federal Law. Visit the International Student Center for more information.

ON-CAMPUS HOUSING/DORMS: None. It is the student's responsibility to find housing. SCC does not have any host families available (ask for information on privately owned business in American host family). SCC is near downtown, William Land Park and within walking distance from many apartment buildings. SCC location is a plus for students!

TRANSPORTATION: You can take Regional Transit bus and light rail directly to City College Station. Or, no matter where you live, you can drive to the nearest Regional Transit light rail station park-and-ride lot and take light rail to the college. SCC ASSESSMENT TESTING: ESSAY + ESL or ENGLISH and MATH TESTS ARE REQUIRED FOR ALL NEW STUDENTS. This is necessary to provide an up-to-date recommendation in your counseling session with the coordinator/counselor to plan towards an A.A. degree and/or transfer of courses to the University.
