STUDENT ELECTION CAMPAIGN INFORMATION

It is imperative you review and comply with all relevant LRCCD Policies and Regulations. Click to link to LRCCD Regulation 2311, Section 5 regarding campaigning. In addition to these regulations, the following rules apply to campaigning and posting. Rules and regulations are in place to ensure a fair election process. Breaking any of the following rules may result in termination of your candidacy and/or other action. The Election/Campaign Violation Report should be utilized to report alleged violations.

Campaign Rules

- Campaigning and the posting of all materials may begin the week prior to elections and will end 24 hours after the close of elections when all materials must be removed (see Election Timeline). You are responsible for removing all of your own campaign materials.
- Your campaign should be positive and focus on you. No negative campaigning in any way, shape, or form will be permitted. Negative campaigning includes foul language, slander, covering up or removing other candidate's postings, or anything that may be considered illegal or unethical.
- Campaigning is not to interrupt the learning environment and is not permitted in the LRC or computer labs. Campaigning in classrooms is by instructor permission only.
- No Student Associated Council (Clubs and Events Board and the Student Senate) materials, supplies, or office equipment may be used at any time for campaigning.

Posting Rules

- All postings require the Student Leadership and Development stamp of approval.
- Banners may be up to 3 x 6 feet in size.
- Posting acceptable with masking or painter's tape only.
- Posting permitted in the following areas: the brick walls outside of Rodda North, Rodda South, Business, Lillard Hall, Student Services, Fine Arts, City Café, and the Student Center.
- Fliers may also be posted on the burgundy/gold checked bulletin boards as follows: hallway outside of RHS 161 and 165; hallway outside of BUS 145, 153, 220, 237; City Café by the north entrance; Student Center.
- No posting on the quad gazebo/hut, windows, glass, trees, light posts, breezeways, doorways, handrails, benches, fountains, planters, and ground.
- Chalking is not permitted.
- Postings anywhere else on campus, or at the West Sacramento and Davis Centers, are based on approval from the appropriate party.
- Postings in a language other than English must be approved well in advance by Kim Beyrer, Coordinator.
- Campaign materials are not to be placed at a height requiring a ladder or mechanical device. Candidates are to be prudent in respect to safety.

Recommendations

- The Student Leadership and Development Workroom (and supplies) may be used for making banners. You may visit South Gym 226 to reserve a time. All candidates are expected to sign-in and follow all Workroom rules.
